ERC has approximately 86,294.92 m² of land at center of Addis Ababa now beingutilized as the head quarter of the corporation. ERC wants to commit this land as are source to this project equity contribution with the land is valued at ETB 12,450,000,000.00 (≈ USD 102,804,540.9) as per the current median market rate of the Addis Ababa City Administration Land and has already taken the initiative to design and get construction permit for the development of office, Hotel Apartment, Commercial Complex (Mall, Cinema, Dinning, Recreation Spaces,...). As per the Feasibility study done on this project all components have small cash flow requirements and high returns on investment with IRR of office building being 12.1932%, IRR of commercial hub building IRR being 16.6%, IRR of hotel apartment building being 38.1899% and IRR of residential apartment building being 27.9996%. On top of the equity contribution with the land, subject to negotiation will be ERC's additional shares within the project as a 'non-Equity contribution shares'whichmightincludespacewithintheofficebuildingtobetransferredtoERC.Alldeveloperscanbring suggestion to the 'non-Equity contribution' percentage points which is subject to negotiation with all potential developers. ERC as government entity and considering the huge investment required ERC will offer incentives like duty free and other income tax relief, subject to negotiation with all developers. So ERC expectations from the potential co-developer is simply a company/ organization / legal person capable of arranging smart construction project financing methods including contractor financing, debt financing and other options.

ERC aims to attract a co-developers the project by ensuring the potential co-developer can enhance ERC's ability to mobilize resources and ensure project realization by emphasizing on the following key points:
