PART A: GENERAL

1. INTRODUCTION ANDBACKGROUND

Railway Transpiration is believed to be the backbone of national economic growth in developing and developed countries. Hence, the Ethiopian government has established the Ethiopian Railway Corporation (known as ERC) by the Council of Ministers regulation No 141/2007 as a public enterprise to construct and operate railway transport in Ethiopia to support the economic growth of the country. Under the leadership and supervision of ERC above 790 km of railway line has been constructed and put into operation, and about 560 km railway line is in the construction phase. Besides infrastructure construction, ERC trained more than 800 staff from TEVT to Ph.D. level in collaboration with Addis Ababa University, abroad universities, and training institutes to fill the skilled manpower gap in the sector.

Moreover, with its commitment to the creation of knowledge base, provision of excelling and sustainable engineering solutions, providing a comprehensive range of engineering services, and addressing &working towards bridging the service delivery gaps in the construction industry in Ethiopia. the corporation's proposal to incorporate a Grade 1 - Engineering Consultancy, Design and Construction (contractor) division in its structure has been approved by the relevant authorities in the previous fiscal year.

To achieve its commitment in construction, ERC has established machinery business unit whose main responsibility is engaging in management and maintenance and repair of the corporation's light and heavy-duty vehicles, construction machineries and equipment.
